AF asked why the club suffer from quite a few injuries. DH said he had been discussing that exact point with PS. He said the injuries are different and there is a difference between freak injuries that are difficult to control and players that pick up injuries more regularly. He said if you recruit players with a big injury history, then there is an increased chance that will continue. He said the club need to focus on players who have a good amount of games played. He said all the positive and negative factors had to be taken into consideration. He said he	
hopes the club have come up with the right balance and that supporters would be the	
judge of that.	
He said if the club priced season tickets to cover increased costs the prices would have to	
be put up substantially. He said that was something the club can't do. He said the lowest	
season ticket price comes out at just under £12.50 a game.	
HA asked what the aim of the pricing is.

right balance for supporters. He said the club need the support of the fans and appreciate
